2. You must not at any time "deface interfere with or remove" the War Memorial on the land or in any way obstruct or interfere with the rights of access to the War Memorial. The bungalow was specifically cpnveyed by the Coal Board subject to the right of all persons entitled to enter upon" the land to maintain and repair the War Memorial .. and of the public to enter upon the land for the purpose of visiting the War Memorial".

I ehclose a copy of a small bundle of correspondence between the late Mr.Green, who died last year, and the Local Authority and others regarding the possible re-siting of the War Memorial in which, as you will see, he proved unsuccessful. I had asked the Vendors Solicitors what arrangements existed for visits to the War Memorial, particularly on Armistice Day; they have no information at all and although I imagine that, from his relative proximity to the property, David may well have information in this conext, it is possible that members of the public may claim that they have the right to come through your front garden to visit the Memorial which may well interfere with your own horticultural plans.

## War Memorial, Sunniside

I refer to your letter of the 9th June 1978. The resiting of this War Memorial has been the subject of discussion by the Council on several occasions over the past years. When it was considered prior to 1974, it was not possible to find a suitable piece of land in Sunniside belonging to the Council where the Memorial could be sited. In view of this, it was decided, when your property was sold by the National Coal Board, to leave the Memorial in situ. I understand that the previous owner bought the property with the covenant that the Memorial should remain in the garden, and as far as I am aware, your purchase would be also subject to this condition. As I understand it, you cannot remove the Memorial without obtaining the permission of the National Coal Board who, no doubt, will be loath to grant permission having regard to the inherent difficulties, e.g. public opinion.

I regret that I can be of no further assistance in this matter.
